

## **Renault – Terms and conditions of the French Chamber of Commerce Renault 4 E-Tech Electric Quiz**

**PLEASE READ THESE RULES AND THE PRIVACY POLICY CAREFULLY AND ONLY PARTICIPATE IF YOU AGREE TO ALL TERMS AND CONDITIONS DESCRIBED HEREIN.**

These Rules (hereinafter referred to as the "Rules") apply to the "French Chamber Event" Renault 4 E-Tech electric quiz competition (hereinafter referred to as the "Game") organised by RN Hungary Kft. (registered office: 1097. Budapest, Könyves Kálmán krt. 34., company registration number: 01-09- 072543, registered with the Budapest General Court, tax number: 10485817-2-44, hereinafter referred to as the "Organiser"), is organised on the premises of the "French Chamber Event" (hereinafter referred to as the "Venue").

By participating in the quiz (hereinafter: the "Game"), the entrant acknowledges and accepts these Rules and agrees to be bound by them.

### **1. Persons participating in the Game**

The Game is open to all natural persons over the age of residence or domicile in Hungary, who fully comply with all the conditions set out in these Rules and who are not subject to any of the conditions for exclusion from the Game (hereinafter referred to as the "Player").

The Game is NOT open to the following persons:

- the owners, officers, employees, agents and agents of the Organiser and the Operator, and all of them, in accordance with the provisions of the Civil Code. 8:1;
- owners, managers, employees, agents of other legal entities or unincorporated organisations directly involved in the operation, and all such persons and entities, as well as the owners, managers, employees, agents of all such persons and entities, as defined in the Civil Code. 8:1.

The Promoter shall exclude from the game any Player who in any way jeopardizes the fair conduct of the game, the Promoter shall not separately notify the Player of the fact of exclusion.

### **2. Description of the Game**

In the Game, the Promoter will award the prize set out in these Rules to those who perform the following activity on the Game Space during the Game Period, up to the limit of the inventory: Players will be required to complete a quiz at the French Chamber of Commerce event venue via the Game Interface

<https://www.renault.hu/erdeklodes/kviz-kamaragala-renault.html>, where they will be asked to answer a question correctly in order to be eligible to enter the prize draw. Participation in the Game is voluntary and free of charge. The Promoter also reserves the right to request information from any Player to investigate any suspected fraud or other illegal conduct by any Player during the Game, or to suspend or exclude any Player from the Game at the unilateral discretion of the Promoter and/or the Promoter (which shall not be obliged to state the reasons for such decision). Players who engage in the unfair conduct set out in this clause shall be liable to compensate the Organiser and/or the Promoter for any damage caused to the Organiser and/or the Promoter in connection with the Game.

### **3. Duration of the Game**

The Game will take place between 15 November 2025 18:00 and 16 November 2025 02:00. Participation in the Game is possible from the start of the Game until the end of the Game.

### **4. Winnings**

Players who comply with the terms and conditions of these Rules will be eligible to win the following prizes:

1 one weekend-long Renault 4 E-Tech electric test drive

A total of 1 winner will receive a prize during the entire game.

The Prize is non-transferable and non-redeemable for cash and cannot be exchanged for any other prize. The Promoter reserves the right to change the Prize.

The Promoter and the winner must cooperate to ensure that any tax liability arising from the prizes is met. In the event of the transfer of the prize (in view of the circumstances thereof), the provisions of Article 76 (3) and (5) of Act CXVII of 1995 on Personal Income Tax shall apply, i.e. the payer shall be liable for the declaration and payment of personal income tax on the prize in view of the provisions applicable during the Game. The Organiser shall be deemed to be the payer, with the proviso that no additional tax burden shall arise in connection with the benefit. The Promoter will not provide any additional prizes in the Game beyond the prizes listed herein

### **5. Selection of winners**

The winner of the Game will be the Player who reaches the predefined level of activity in the Game Area during the Game and is drawn by the Game Organizer in a draw.

## **6. Receiving the prize**

The Winning Player will be able to collect his/her prize after the draw following an email notification at a pre-arranged location and time.

## **7. Responsibility**

The Promoter excludes its liability for quality defects and malfunctions of the prizes, unless the exclusion of liability is expressly prohibited by Hungarian law.

The Organizer and the Promoter exclude all liability for any claims for compensation or indemnification for any costs, damages or losses arising from or related to participation in the Games, any errors, defects, malfunctions, delays or delays in the operation of the Game. The Player, by participating in the Game, expressly waives any and all claims against the Promoter, the Promoter or any third party in connection with the conduct of the Game, the selection of the winners, the prizes, the winners.

Furthermore, the Organizer and the Promoter shall not be liable if the Game or the website containing the Game and these Rules are temporarily unavailable for technical reasons during the duration of the Game. The Organizer and the Promoter shall not be liable for any errors and their consequences arising from causes beyond their control (such as technical failures or outages in the Internet network).

If, as a result of or in connection with the Player's conduct, any third party or any authority or court brings any claim or proceeding against the Organizer or the Operator, the Player shall take all actions required by the Organizer or the Operator and shall compensate the Organizer and the Operator for any damage, material loss and costs suffered by them as a result of or in connection with any unlawful conduct of the Player.

## **8. Other provisions**

The Promoter reserves the right to unilaterally change or withdraw these Rules without prior notice, and to cancel the Game without giving any reason. Informs on the Game Space that the present Game is not subject to the Act XXXIV of 1991 on the organisation of games of chance
